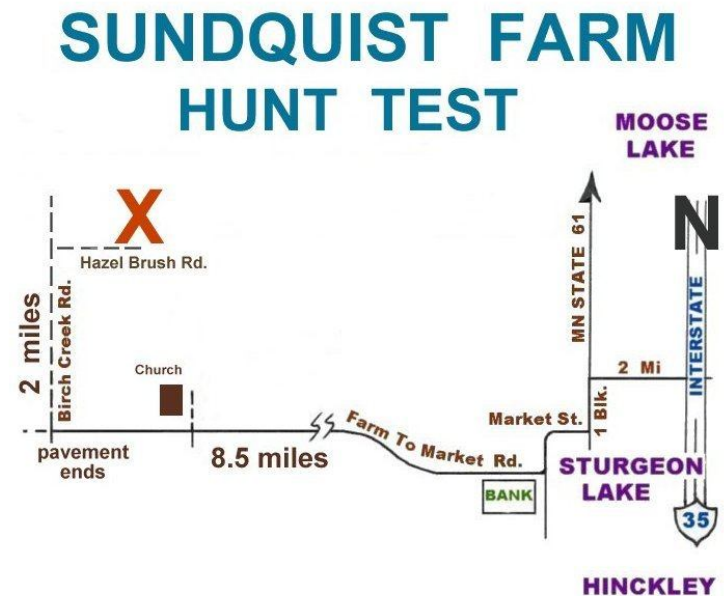
#### Directions to Hunt Test area from the South;

From I-35 at the Sturgeon Lake exit go west on CR46. CR46 will "T" into HWY 61 2 miles from I-35. Turns left and go south into the town of Sturgeon Lake-1 block on Hwy's 46&61. In sturgeon Lake CR46 will separate from 61 and go west. Turn West (right) from Hwy 61 and follow CR46 8.5 miles to Birch Creek Rd. (CR169). Turn right and go north to the Hunt test grounds....approximately 2 miles.

#### Directions to Hunt Test area from the North;

From the first exit off I-35 follow MN27 into Moose Lake then out or town on MN27 & 73. At the MN27 & 73 split follow MN27 west approximately 6.5 miles to Split Rock Road. Go south approximately 3 miles to Hunt Test area.
